


STUDY | WORK | RESIDENCY GUIDE

Purpose: Nonimmigrant visa (NIV) students and staff at Florida Polytechnic University may use this as a quick reference guide to determine NIV students' eligibility to study, work, or apply for residency for tuition purposes. It is the responsibility of the student to be aware of their eligibility and restrictions. This guide is for informational purposes only and does not constitute as legal advice. An attorney or professional with expertise in immigration regulations must be contacted for additional assistance.

Resources: The <u>Department of Homeland Security (DHS) – Study in the States</u> website has resources to explain the rules and regulations for F and M visa students studying in the US. The <u>US Immigration and Customs Enforcement (ICE) – Student and Exchange Visitor Program (SEVP)</u> website has information and regulations for F and J visa students studying in the US. The <u>US Department of State (DOS)- Bureau of Consular Affairs</u> website is the source of all visa programs, international travel, advisories, US passports, and other news. The <u>United States Citizenship and Immigration Services (USCIS)</u> is the source of all immigration policy, forms, and information.

Residency Petition: If your status indicates eligibility to petition for Florida Residency, new students must <u>Apply for Residency</u> when submitting their application for admission. Current students must apply for <u>Residency Reclassification</u> with the Registrar's Office.
