

## Travel Guidelines Overview

F-1 students are permitted to depart the United States (US) if they are eligible and intend to return to continue to study in the next consecutive semester. Students must notify their Designated School Official (DSO) of their intention to travel outside the US **no less than 5 days prior to travel** to obtain the required travel endorsement (signature) on page two of their I-20.

The I-20 with a DSO travel signature and other required documents must be presented at the port-of-entry to be allowed re-entry into the US. This is to verify your F-1 status and intentions to continue studying full-time in the US.

- **Students are responsible for checking [Travel Advisories](#) and to see if there are any [COVID-19 International Travel Advisories](#) when traveling at all times.**

US Customs and Border Patrol (CBP) officers determine your eligibility to enter the country. Students are encouraged to have a back-up plan in case they are required to remain abroad, self-isolate or quarantine for a specified number of days.

**DSO TRAVEL ENDORSEMENT:** Also called “DSO travel signature” is the DSO’s signature on page two of the I-20, which confirms you (**and any F-2 dependents**) are eligible to return to the US to study and allows you to re-enter the US for study.

**TRAVEL SIGNATURE VALIDITY:** Travel signatures are valid 12 months from the DSO travel signature date. If you are on **OPT**, then your travel signature **is valid for 6 months only**. Once expired, students must request a new travel signature.

**TRAVELING WITHIN THE US:** Special permission is **not** required to travel within the US. However, it is recommended to travel always with your passport, I-94, and I-20 whenever you travel within the US.
